1/1/2010 - LIMITED WAIVER OF FILING FEES FOR EXPUNCTIONS
Requires that the fees under Subsection (a) (relating to requiring a petitioner seeking expunction of a criminal record to pay a certain fees) **be waived if the petitioner seeks expunction** of a criminal record that relates to an arrest **for an offense of which the person was acquitted**, other than an acquittal for an offense described by Article 55.01(c) (relating to prohibiting expunction of records for certain persons) **AND the petition for expunction is filed not later than the 30th day after the date of the acquittal.**
