

**AMENDED
RESOLUTION NUMBER 2017-18**

A RESOLUTION BY THE CITY COUNCIL OF THE CITY OF HALLSVILLE AMENDING RESOLUTION 2017-11 ORDERING A REGULAR GENERAL ELECTION TO BE HELD ON NOVEMBER 7, 2017 FOR THE PURPOSE OF ELECTING A MAYOR AND TWO ALDERMEN; DESIGNATING THE POLLING PLACES FOR EARLY VOTING FOR SAID ELECTION; AND DESIGNATING DETAILS RELATING TO THE EARLY VOTING OF SAID ELECTION.

WHEREAS, the City Council of the City of Hallsville enacted Resolution 2017-11 on August 15, 2017; and

WHEREAS, upon review of such resolution, the Harrison County Elections office has requested certain revisions and corrections; and

WHEREAS, the City Council of the City of Hallsville hereby amends Resolution 2017-11 to make certain revisions and corrections as requested by the Harrison County Elections office.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HALLSVILLE THAT:

1. Revisions to Resolution 2017-11.

- a. Section 7 Polling Place of Resolution 2017-11 shall be amended to read as follows:

“Section 7 - POLLING PLACE The election shall be held in the regular voting precinct established by the City, at the Hallsville VFD ESD #5, 102 North Central Street, Hallsville, Texas.”

- b. Section 8 Polling Place – Early Voting of Resolution 2017-11 shall be amended to read as follows:

“Section 8 – POLLING PLACE – EARLY VOTING The City of Hallsville hereby designates one (1) early voting polling place location for early voting by personal appearance at 102 North Central Street, Hallsville VFD ESD #5.”

- c. Section 11 Early Voting Period Held of Resolution 2017-11 shall be amended to read as follows:


“Section 11 – EARLY VOTING PERIOD HELD early voting polling place location shall be opened on the following dates:

October 23 - 27, 2017	Monday through Friday	8:00 a.m. – 5:00 p. m.
October 30 – 31, November 1, 2017	Monday through Wednesday	8:00 a.m. – 5:00 p.m.
November 2, & 3, 2017	Thursday and Friday	7:00 a.m. – 7:00 p.m.”

2. Effective Date. This Resolution amendment shall be effective as of the date of adoption set out below.

3. Amend Prior Resolution. This ordinance is intended to and hereby does amend prior Resolution 2017-112 of the City Council of the City of Hallsville, Texas. Except as specifically set out herein, Resolution 2017-112 of the City Council of the City of Hallsville continues in force as written.



Applications for ballot by mail must be received (not postmarked) no later than the close of business on August 21, 2017.


