

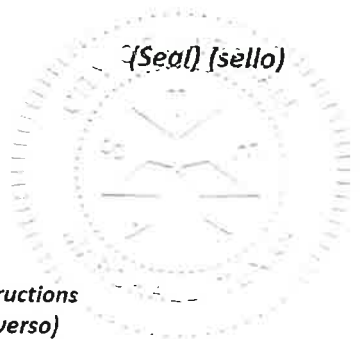

Ordinance No. 387

The City of Waskom, Texas ordered an election to be held on May 4, 2024 for the purpose of electing three Alderman. 2.053 of the Election Code states that the governing body of the political subdivision by order or ordinance may declare each unopposed candidate elected to office.

WHEREAS, THE City Secretary has certified to the governing body that there is no opposition candidate to Russell Wayne Allbritton, for the position of Mayor.

WHEREAS, THE City Secretary has certified to the governing body that there is no opposition candidate to Jesse W. Moore, for the position of Alderman.

WHEREAS, THE City Secretary has certified to the governing body that there is no opposition candidate to Tommy Lee Philpot, Sr., for the position of Alderman.

BE IT ORDAINED by the Board of Aldermen of the City of Waskom, Texas:

Section 1: That the Board of Aldermen has reviewed the certifications of the City Secretary and hereby declares that Russell Wayne Allbritton, Jesse W. Moore, and Tommy Lee Philpot, Sr. are elected to the office of Mayor and Alderman.

Section 2: That the Board of Aldermen hereby declares that no City Election will be held on May 4, 2024, since there are no opposing candidates.
